The San Diego County Office Board of Education invites highly qualified educational leaders to apply for the County Office of Education Superintendent position.

PROFESSIONAL PROFILE

San Diego County Office Board of Education seeks a superintendent who:

- Has experience leading and supporting systems that are aligned with our North Star to ensure all students, especially our historically marginalized and students experiencing poverty receive the premium education and support all students deserve
- Has a demonstrated commitment to equity and a willingness to address systemic issues and barriers to student success with the goal of eliminating poverty
- Prioritizes diversity, inclusion, and social justice
- Understands trauma-informed care and is an advocate for restorative justice
- Sees labor organizations as partners who are essential to a healthy working environment for all employees and values the perspective they bring to the table
- Is a collaborator who actively seeks and values the input of students, staff, parents and diverse community partners and will bring the entire community together toward a strong vision of student achievement
- Is politically savvy and demonstrates knowledge of the legislative process
- Is dedicated to student success and committed to continuous learning and growth for all students, staff and families
- Has a demonstrated passion for supporting students' holistic development with an emphasis on student academic success and well-being
- Has experience in oversight of school district finances, budgets, and business management
- Is knowledgeable of outreach strategies and best practices for improving student and family engagement
- Fosters, supports and promotes community partnership opportunities
- Is knowledgeable and supportive of court and community schools and prioritizes the needs of marginalized students
- Is accessible, visible and actively engaged at the county office of education sites, in schools and classrooms throughout the county and at various community and partner events

SELECTION PROCESS

The San Diego County Board of Education has retained Consultants Sandy Sánchez Thorstenson, Eric Andrew, Ed.D., and Blanca G. Cavazos, Ed.D. of Leadership Associates, to recruit qualified candidates. The consultants will screen applications and recommend candidates to the board for interviews and further consideration. The board will have the opportunity to review all applications submitted. Any contact with board members, in an attempt to influence the selection process, will be considered a breach of professional ethics. Finalists will have an opportunity to familiarize themselves with the community and San Diego County Office of Education. Board members reserve the right to visit the district/county office of education and communities of a candidate prior to a final decision.

SALARY AND CONTRACT

The salary will be competitive and based upon qualifications and experience. The approximate range is \$335,711 – \$408,060. A multi-year contract will be considered.

To be considered, the candidate must provide:

- A letter of introduction
- A fully completed application form
- A resume
- Three current letters of recommendation (within the past 12 months)
- Verification of degrees and credentials (finalists only)

THE SAN DIEGO COUNTY OFFICE OF EDUCATION

The San Diego County Office of Education is committed to our North Star, our mission to attack structural poverty through developing a genuine sense of belonging for every student, and providing high expectations, social justice, and equity for all. Our priority is to raise the achievement of all students through the elimination of the opportunity gap that negatively impacts our students, especially those of color. We accomplish this through the delivery of culturally and linguistically responsive standards-driven instruction, courageous and advocacy-oriented leadership, and relevant professional learning. All Juvenile Court and Community Schools (JCCS) community members stand personally committed and professionally accountable for the achievement of this mission.

The San Diego County Office of Education (SDCOE) runs a variety of educational programs including:

Juvenile Court and Community Schools - These schools serve approximately 1,774 students each year in 21 sites and classrooms throughout the county.

The WASC-accredited program serves school-age youth who are either wards of the court, including those who are incarcerated or have been referred by social services, probation, or one of the 42 school districts in San Diego County. In addition, our educational services are provided

to youth impacted by expulsion, incarceration, pregnancy/early parenting, foster care, chronic truancy, substance dependency, neglect, abuse, and homelessness.

Monarch School is a K-12 public school serving the needs of children impacted by homelessness. The only school of its kind in the county, Monarch is a unique public-private partnership between SDCOE/JCCS and the nonprofit Monarch School Project, a 501(c)3 organization; SDCOE provides teachers and an accredited education, and the nonprofit supplements this program through academic and enrichment programs including an after-school program, expressive arts therapy, and counseling.

San Pasqual Academy in Escondido is a residential campus that is seeking to serve approximately 50 teens in foster care. It opened in 2001 and was the first school in the country to specifically serve this population. It is in the midst of a transition to a new in-home service provider that seeks to significantly expand the program.

Friendship School serves as many as 50 students between the ages of 3 and 22 who are medically fragile and have multiple disabilities. The Imperial Beach campus is operated by SDCOE in affiliation with the South County Special Education Local Plan Area (SELPA).
